A SPECIAL MEETING OF THE MAYOR AND CITY COUNCIL OF THE CITY OF PERU,
NEMAHA COUNTY, NEBRASKA, is hereby called to be held at the City Hall at 614 5th Street
in the City of Peru, Nemaha County, Nebraska, on the 3rd of June, 2025 at 6:30 P.M. for the
following object and purposes, which shall constitute the agenda for said meeting. The Open
Meetings Act is posted.

Roll Call:

A. Park & Rec is seeking Approval to purchase: two battery powered motion detector
lights for the restrooms for the ball tournament, and masks for use during the cleaning of
the bathrooms and concession stand building. Council Member T. Westfall motioned to
approve; the motion was seconded by R. Brown No discussion was had. Upon roll call vote
3 AYES, 0 NAYS, 1 ABSENT. The following voted AYE, R. Brown, T. Westfall, J. Whisler. The
following voted NAY: Motion Carried.

B. Park & Rec is seeking Approval: to use the city's generator to power the concession stand
building during the ball tournament. Council Member T. Westfall motioned to approve; the
motion was seconded by J. Whisler, no discussion was had. Upon roll call vote 3 AYES, 0
NAYS, 1 ABSENT. The following voted AYE, J. Whisler, R. Brown, T. Westfall. The following
voted NAY: Motion Carried.

C. Ordinance 2025-07 Park & Rec is seeking Approval to become a committee and dissolve
the commission. (suspension of rules) AN ORDINANCE OF THE CITY OF PERU,
NEBRASKA REPEALING MUNICIPAL CODE SECTION 32.05, BOARD OF PARK
COMMISSIONERS AND ALL ORDINANCES OR PARTS OF ORDINANCES IN
CONFLICT WITH THIS ORDINANCE; STATING THE EFFECT OF THE REPEAL OF
MUNICIPAL CODE SECTION 32.05; CREATING A PARKS AND RECREATION
COMMITTEE; DEFINING DUTIES AND TERMS; AND DECLARING AN EFFECTIVE
DATE FOR THIS ORDINANCE. The Mayor announced that the introduction of the proposed

Ordinance 2025-07 is now in order. Councilmember T. Westfall moved that these proceedings will be kept in a separate and distinct volume known as the "Ordinance Record of the City of Peru," and that said volume be made part of these proceedings the same as though it were spread at large herein, said motion was seconded by R. Westfall moved to suspend rules for Ordinance 2025-07; Council member J. Whisler seconded for the suspension of rules. Upon roll call vote: 3 AYES, 0 NAYS, 1 ABSENT. The following Council Members votes "AYE" R. Brown, T. Westfall, J. Whisler, the following voted Nay: none Motion Carried. The Mayor declared the statutory rules in regard to the passage and approval of Ordinances be suspended so that Ordinance No. 2025-07 might be introduced, read by title and then moved for final passage as the same meeting. Proposed Ordinance No. 2025-07 now comes on for reading. Council Member: T. Westfall read Ordinance 2025-07 AN ORDINANCE OF THE CITY OF PERU, NEBRASKA REPEALING MUNICIPAL CODE SECTION 32.05, BOARD OF PARK COMMISSIONERS AND ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT WITH THIS ORDINANCE; STATING THE EFFECT OF THE REPEAL OF MUNICIPAL CODE SECTION 32.05; CREATING A PARKS AND RECREATION COMMITTEE; DEFINING DUTIES AND TERMS; AND DECLARING AN EFFECTIVE DATE FOR THIS ORDINANCE. AND ORDERING THE PUBLICATION OR POSTING OF THE ORDINANCE. Council member T. Westfall moved for final passage. Motion was seconded by council member J. Whisler. Discussion was had, K. Novak asked that this ordinance be tabled until the June 16th, regular meeting, R. Brown said she would like to here from some on the council themselves. Upon roll call vote: 2 AYES, 2 NAYS, 1 ABSENT, the following Council Members votes "AYE" T. Westfall, J. Whisler, the following voted NAY R. Brown, K. Novak. The Motion Failed.

D. For discussion and approval: of the street bid to repair the culvert of Park Avenue. Council Member T. Westfall motioned to approve; the motion was seconded by J. Whisler, no discussion was had. Upon roll call vote 3 AYES, 0 NAYS, 1 ABSENT. The following voted AYE, J. Whisler, R. Brown, T. Westfall. The following voted NAY: none. Motion Carried.
