The Mayor and Council of the City of Peru, Nemaha County, Nebraska, were called to meet at City Hall at 614 5th Street, Peru, Nebraska 68421, on the 16th of January 2024, at 6:00 P.M., for a Regular Council Meeting, open to the general public, advance notice of said regular meeting, the designated method of giving notice, including the agenda for said meeting, or the availability thereof was posted at: Peru City Hall, Western National Bank (Bank of Peru), Peru Post Office, and Casey's General Store.

Westfall introduced the proposed ordinance as Ordinance No. 2023-15 entitled: AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PERU, NEBRASKA, AMENDING THE ORIGINAL CHAPTER 32 OF THE MUNICIPAL CODE OF THE CITY OF PERU, NEBRASKA CODE OF ORDINANCES BY ADDING AN ADDITIONAL SECTION WHICH SHALL BE ENTITLED "32.07 BOARD OF PARK AND RECREATION COMMISSION"; TO PROVIDE A POLICY FOR THE CREATION, ORGANIZATION, OPERATION, AND FUNDING OF A PARK AND RECREATION COMMISSION; TO PROVIDE FOR THE REPEAL OF CONFLICTING ORDINANCES OR SECTIONS THEREOF; ORDERING THE PUBLICATION OR POSTING OF THE ORDINANCE' AND TO PROVIDE FOR AN EFFECTIVE DATE. Having read Ordinance No. 2023-15, Councilmember K. Novak moved for its approval on its third and final reading and its title agreed to, which motion was seconded by Councilmember Q. Kieler. Upon roll call vote: 4 AYEs and 0 NAYs. The following Council Members voted "AYE" B. Brown, K. Novak, Q. Kieler, and T. Westfall. Motion: Carried.

Agenda Item 7 – NEW BUSINESS

L.) Report: City Clerk T. Schuetz

City Clerk T. Schuetz provided an update that the City is working on finalizing and closing some grants projects, in order to create space for new projects. Additionally, T. Schuetz has met with other jurisdictions regarding code enforcement. Due to the items needed for code enforcement (technology, tags, training, etc), the City likely will not be able to prepare and hire for that position until late summer, or after the end of the fiscal year.

M.) Motion for Consideration by Council: Approval of chosen proposed bid for Leased Farm Ground, published as required, identified within Parcel I.D. Nos. 640060641 and 640060609. Property owned by the City of Peru, described as: 240 acres of bottom-ground owned by the City of Peru, Nemaha County, Nebraska, Parcel Identification Numbers: 640060641 and 640060609. Discussion was held regarding the bids, and the current back-owed taxes that are due, as well as the bids received, and what may be in the City's best interest.

With no more discussion to be had, Councilmember T. Westfall moved for a vote on approval for a 3-year, \$280/acre cash rent lease of the farm ground for Mr. R. Trail, seconded by Councilmember Q.
