- M. Discussion and Possible Action: Purchasing jersey barriers for city burn dump in order to be able to close it off and control what gets dumped there. \$1,500.00 (50 @ \$30.00). Councilmember T. Westfall motioned to approve the purchase, seconded by Councilmember J. Whisler. Discussion was had regarding the problem with illegal dumping that can result in massive fines. This will result in a permanent solution to securing the dump. Upon roll call vote: 3 AYEs and 0 NAYs. The following Council Members voted "AYE", T. Westfall, B. Brown, and J. Whisler, The following voted NAY: None. Motion: Carried.
- N. Discussion and Possible Action: Permission to apply for the Downtown revitalization grant that opens Jan 2nd, 2025, and to work with the Businesses and City to create a plan. T. Westfall motioned to approve the permission to apply, seconded by Councilmember B. Brown Upon roll call vote: 3 AYEs and 0 NAYs. The following Council Members voted "AYE", B. Brown, T. Westfall and J. Whisler, The following voted NAY: None. Motion carried.
- O. Discussion and Possible Action: Permission to work with SENDD and the College to pursue and create a plan to apply to the Housing Rehab and Building Program through the State of Nebraska. T. Westfall motioned to approve the permission to apply, seconded by Councilmember J. Whisler. Upon roll call vote: 3 AYEs and 0 NAYs. The following Council Members voted "AYE", T. Westfall, B. Brown J. Whisler, The following voted NAY: None. Motion carried.
- P. Approval: To complete the City Hall restroom rehab, finish making it ADA Compliant no more than \$2,000.00 from the LID fund. The ADA upgrade was approved several year ago, and some work was done in the summer of 2024. What remains is relocating the door to make it wider, new flooring, painting the walls, replacing rusted out fixtures and broken exhaust fans and installing an ADA compliant toilet in the lady's room. J. Whisler motioned to approve the completion of the restroom rehab, seconded by Councilmember T. Westfall. Upon roll call vote: 3 AYEs and 0 NAYs. The following Council Members voted "AYE", J. Whisler, B. Brown, T. Westfall, The following voted NAY: None. Motion carried.
- Q. Discussion and Possible Action: Individual email Accounts for council members. Councilmember T. Westfall motioned to approve the creation of city emails for the council, seconded by Councilmember B. Brown. Discussion was had: As elected officials the communication on behalf of

the city is subject to the Freedom of information act. As such, it would be beneficial to create council specific emails for all the council members. The additional email addresses add an extra \$4 a month to the Microsoft bill. The additional advantage is that these remain property of the city and can be passed on to the next elected official. Upon roll call vote: 3 AYEs and 0 NAYs. The following Council Members voted "AYE", B. Brown, T. Westfall, J. Whisler, The following voted NAY: None. Motion carried.

R. Approval of bid for cleaning City Hall: Councilmember T. Westfall motioned to approve the bid for cleaning of the City Hall, seconded by Councilmember B. Brown. Discussion was had: A bid request was published in the paper, one was received. This is for a once-a-week cleaning, during office hours, City Hall supplies the cleaning supplies, estimate 3 hours a week. The bid that came in was for \$80 a week. A contract will be drawn up by the attorney. Upon roll call vote: 3 AYEs and 0 NAYs. The following Council Members voted "AYE", J. Whisler, B. Brown, T. Westfall, The following voted NAY: None. Motion carried.

S. DISCUSSION AND POSSIBLE APPROVAL: Bid from Burton Asphalt, LLC for FEMA Projects # 98930 (2 City Streets), 97986 (Walnut), 98015 (Olive Street Bridge & Trailhead), 97503 (6 Streets & Bridges) at \$138,897.50. FEMA has prepaid \$135,021.16 with \$15,000.35 remaining to collect. Which leaves \$11,127.01 for grant management. T. Westfall motioned to accept the bid from Burton Asphalt to repair streets on the north end, seconded by Councilmember J. Whisler. Discussion was had: These repairs have to be done, or the City will need to send back the funds. The bid is within the scope set out by FEMA. Pending approval, a formal contract to be created and approved by the City Attorney. Upon roll call vote: 3 AYEs and 0 NAYs. The following Council Members voted "AYE", T. Westfall, B. Brown, J. Whisler, The following voted NAY: None. Motion carried.

Agenda item 15: Approval: A RESOLUTION DESIGNATING SIGNERS ON CITY BANK ACCOUNTS; TO PROVIDE FOR OTHER RELATED MATTERS; REPEALING ANY CONFLICTING RESOLUTIONS OR SECTIONS THEREOF; AND TO PROVIDE FOR AN EFFECTIVE DATE. RESOULITION 2024-20. Council Member T. Westfall motioned to approve Resolution No. 2024-20. Said motion was seconded by Council Member J. Whisler. Upon roll call vote: 3 AYEs, 0 NAYs. Agenda item 16 - Proposed Ordinance No. 2024-08 was presented for consideration on its second reading. The Mayor announced that the proposed ordinance was in order. Councilmember T. Westfall moved that these proceedings be kept in a separate and distinct volume known as the "Ordinance Record of the City of Peru," and that said volume be made part of these proceedings the same as though it were spread at large herein, said motion was seconded by B. Brown. Upon roll call vote: 3 AYES, 0 NAYS. The following voted "AYE": T. Westfall, B. Brown, J. Whisler. Motion Carried. Council Member T. Westfall introduced the proposed ordinance as Ordinance No. 2024-08 entitled: AN ORDINANCE FOR THE MANAGEMENT, PLANTING, MAINTENANCE, AND PROTECTION OF TREES ON PUBLIC PROPERTY; ESTABLISHING THE CITY OF PERU, NEBRASKA AS A TREE CITY; ESTABLISHING STANDARS, PROHIBITING DAMAGES, DECLARING CERTAIN TREES A NUISANCE, PROVIDING FOR ENFORCEMENT AND

PENALTIES; PROVIDING FOR THE REPEAL OF ALL PRIOR ORDINANCES IN CONFLICT HEREWITH; ORDERING THE PUBLICATION OF THE ORDINANCE IN PAMPHLET FORM; AND TO PROVIDE THE EFFECTIVE DATE HEREOF. Having read Ordinance 2024-08, Councilmember T. Westfall moved for its approval on its second reading and its title agreed to, which motion was seconded by Councilmember B. Brown. With no further discussion roll call. Upon roll call vote: 3 AYEs, 0 NAYs. The following Council Members votes "AYE" B. Brown, T. Westfall, J. Whisler The following voted Nay: none. Motion Carried. The Mayor declared that said Ordinance No. 2024-08 be approved on its second reading and its title agreed to.
