# MINUTES OF A REGULAR MEETING OF THE MAYOR AND CITY COUNCIL OF PERU, NEBRASKA ON THE 30<sup>th</sup> OF SEPTEMBER 2024 AT 6:00 P.M.

Meranda Decker stated that they would make 5<sup>th</sup> street look spruce up, have some nice stuff and coordinate with our trunk or treat event at the end of the month. There are 9 wooden light poles on two blocks here on 5th Street, the thought is to ask Community members and businesses that are right outside the polls to 'Adopt-A-Poll' and decorate it to make it festive. The actually do not have one available, the one that was set aside for the City was actually sold out from under us. So, another machine was found from a different dealer and it is actually a bigger machine, and the dealership is 40 miles closer to us. The lease is \$1,000 more a year, no lower price was found.
