None. Motion: Carried

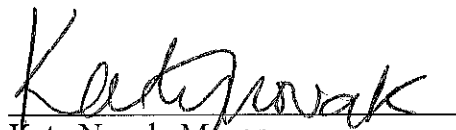
C. Approval of temporary liquor license for KJ Whitehorse for a Beer Garden and Street
